
## Sumitomo Mitsui Auto Service, Cedyna and Mitsui Real Estate Sales form business alliance

A first for the auto leasing industry! Pay car parking charges on credit with corporate members' gasoline card "SS Card"

Sumitomo Mitsui Auto Service Company Limited (Head Office: Shinjuku-ku, Tokyo; President and CEO: Makoto Sato; hereunder, "Sumitomo Mitsui Auto Service"), Cedyna Financial Corporation (Head office: Nagoya, Aichi Prefecture; President and Representative Director: Hajime Yamashita; hereunder, "Cedyna") and Mitsui Real Estate Sales Company Limited (Head Office: Shinjuku-ku, Tokyo; President and Representative Director: Minoru Sato; hereunder "Mitsui Real Estate Sales") is, as of Tuesday, February 1, in tie up for providing a deferred payment service. With this service, it is possible to make a lump sum payment on credit to cover hourly car parking charges at Mitsui Repark, operated by Mitsui Real Estate Sales, using the "Sumitomo Mitsui Auto Service SS Card", a Sumitomo Mitsui Auto Service corporate members only gas card issued by Cedyna.

The SS Card is a gas card already been issued to customers due to an existing tie-up between Sumitomo Mitsui Auto Service and Cedyna; around 70,000 cards have been issued to corporate member organizations. Using this card, Customers can make a lump sum deferred payment for their fuels and gasoline at gas stations all over Japan<sup>2</sup>, thereby streamlining the administration involved in refueling vehicles. Through this business alliance, Sumitomo Mitsui Auto Service's corporate member organization will be able to see the benefits of going cashless and simplifying expense claims management, as it becomes possible to settle gas charges and car parking charges in one-simple payment.

Also, with the introduction of this service, which is a first in the auto leasing industry, Sumitomo Mitsui Auto Service is willing to improve customer service with a double function card, gasoline payment function and an hourly car parking fee payment function – a first in the auto leasing industry; Cedyna is willing to expand the use of its SS Card; and Mitsui Real Estate Sales is willing to create the opportunity for Sumitomo Auto Service's corporate members to use its parking lots.
